


What is Copperwood Mine?

Highland Copper, an inexperienced Canadian mining company, is proposing a 323 acre metallic sulfide mine in Michigan's Porcupine Mountains, abutting and underneath the state's largest old growth wilderness park. The mine facility will include explosive plants, sewage lagoons, and exhaust systems. Mine facilities, including toxic tailings piles, are proposed to be built as close as 100 ft from Lake Superior. Highland Copper has already been reported to work illegally without permits. ¹

Boom-and-Bust:

Copperwood Mine is only slated to have a ~10 year lifespan, but is predicted to leave over 30 million tons of toxic mine waste in unprecedented proximity to Lake Superior. ²Research suggests that the boom-and-bust operation will leave the community poorer than it started ³--logical for a region that is famed for its environmental tourism. All this for copper that will be shipped to Canada, with no promise of return.⁴

Waste:


Copperwood's ore grade is a mere 1.45%. For every ton of copper extracted, only 30 lbs would be copper and 1,970 lbs would be waste, containing at least 15 toxins, including arsenic, cadmium, selenium, lead, and mercury. Tailings piles are permitted to be stored directly upstream of Lake Superior. All infrastructure — including the waste dam — is designed to anticipate 1-in-100

year storm events. There have been two 1-in-1000 year storm events in the

Risk of Toxic Runoff and Treaty Rights Violations:

immediate area in just the last decade.⁶⁷

A model created by the Great Lakes Fish and Wildlife Commission shows that, in the event of a dam rupture, a flood of toxic mine waste cwould reach Lake Superior in as fast as 21 minutes, and would very likely reach the Presque Isle River in Porcupine Mountains State Park.⁸ The mine is proposed in 1842 Treaty Territory. Despite the high risk of flooding, there has been no assessment of its impact on the Anishinaabeg treaty rights to fish in Lake Superior.

Keweenaw Land Association (KLA)

Overview: The Keeweenaw Land Association is the owner of most (if not all) of the mineral properties for Copperwood. They are also likely the dominant mineral owner in all of MI (10% of mineral rights in the UP by land area) so will likely be involved in any project involving mineral rights in MI.

Specific lease details: KLA has a lease & royalty agreement for 6,173 acres of mineral rights with Highland Copper. "These leases have been in place since 2008, and the lease amounts escalate each year resulting in higher annual rental payments (2024 total was \$349,700). The leases expire in 2028, 2035 and 2037. Most of their revenue comes from these leases, they don't have enough passive revenue to cover overhead costs, and are burning through 160K+/yr. If Copperwood starts production, the mineral leases will convert to a royalty-based arrangement based on the amount of copper produced by the mine annually for the life of mine." KLA previously made approximately \$500M from royalties from the White Pine Mine, but they think "There are a number of factors weighing against near-term development of the Copperwood Project and as a result, the Copperwood Project could face significant delays and ultimately prove to be unprofitable or fail to yield the expected cash revenues." ²⁰ ²¹ ²²


